III. XCEL PROGRAM

The Xcel committee submitted several recommendations to be reviewed by the NJ SACC and his staff.

- a. All Local / Invitational Meets for Bronze, Silver, Gold, Platinum and Diamond Levels require a 1-judge panel with a USA G optional rating.
- b. All Local / Invitational meet's, it is highly recommended that the meet host use NAWGJ Judges assigner when acquiring judges.
- c. NAWGJ State Judging Director will assign judges for all State Meets.
- d. For all levels at States a two Judge panel with USA G optional rating will be used.
- e. Qualifying score to States 33.00.
- f. Awards as per USAG guidelines.
- g. Entry fees for Bronze, Silver and Gold \$65.00.
- h. Entry fees for Platinum and Diamond \$75.00.

Level 7 being an optional level some committee members felt that there was a need to have a four-judge panel at States. State treasurer to review financial status, see if this can be financially supported.
